Are you thinking of buying or selling property?

Compliance Certificates are typically requested when real estate is sold. A Compliance Certificate is confirmation from the Town of St. Paul that any existing development located on the subject property meets the regulations under the Land Use Bylaw. Application forms (and policy) can be obtained from the Town of St. Paul's website and must be submitted along with two original Real Property Reports prepared by a registered Alberta Land Surveyor. Please allow a minimum of 10 business days for processing. The fee for a Compliance Certificate is \$125.00.



Assessment Roll Now Open for Review

In accordance with section 302 of the Municipal Government Act, the 2018 Assessment Roll for the Town of St. Paul has been prepared and is now available for review by any person at the main reception desk at the Town of St. Paul Administration Office (5101 - 50 Street) during regular business hours.

The Assessment Roll contains the assessed value of all properties within the Town of St. Paul; whether the assessed value is a parcel of land, an improvement, or a parcel of land and the improvements to it; the assessment class; and a description sufficient to identify the location of the property.
