The first quarter financial variance report was brought to Council last Monday night for our review. You can review this report in the meeting agenda package online.

With regard to the implementation of the cannabis amendments to our Land Use Bylaws, the process is well underway. We have started the process of gathering input from stakeholders and hope to have a draft amendment to be discussed at a public open house by late summer. There is so much to consider and we are working hard to get it right. Of course none of our work can come into effect until the federal legislation comes into force, (projected date is likely September) but our plan is to be ready with a completed bylaw amendment when that time comes.

Our public works staff are busy with this year's approved projects and we ask for your patience in dealing with lane closures and detours. Our construction season is short and we have to do as much as we can while the summer season is here, and the weather is cooperating.

I have received a few calls lately from residents complaining about dog feces left in parks, sidewalks and walking trails. I have no doubt that the majority of dog owners are responsible owners in every sense of the work, but there are always a few that give the rest of us a bad name. Town of St. Paul Dog Control Bylaw 1174, section 6.9, prohibits any dog owner from leaving dog feces on any public lands, or private other than their own. I respectfully ask you to pick up after your dog and not leave their mess for others to deal with.

At our next Council meeting we will have the public hearing for our Councillor Code of Conduct Bylaw. For those of you interested in having some input into the bylaw that will identify the standards to which we, as your council will hold themselves, please feel free to attend. The draft bylaw is in last week's Council agenda package for anyone interested in taking a look. Enjoy your summer.

NOTICE OF PUBLIC HEARING

Take notice that the Council of the Town of St. Paul is proposing to pass a bylaw pursuant to Section 146 and 606 of the Municipal Government Act. The purpose of the public hearing is to obtain public input on the proposed bylaws:

Bylaw No.: 1249

Short Title: Council Code of Conduct

Description: The purpose of the Council Code of Conduct is to establish standards for the ethical conduct of Members relating to their roles and obligations as representatives of the Municipality and a procedure for the investigation and enforcement of those standards. The establishment of the code is consistent with the principles of transparent and accountable government.

Bylaw No.: 1250

Short Title: Advertising Bylaw

Description: The purpose of the Advertising Bylaw is such that Council must give notice of certain bylaws, resolutions, meetings, public hearings or other things by advertising in a newspaper or other publication circulating in the area, mailing or delivering a notice to every residence in the affected area or by another method provided for in a bylaw under section 606 of the Municipal Government Act (MGA).

Time: 7:30 p.m.

Location: Town Hall (5101-50 Street) Council Chambers, Town of St. Paul

Anyone who is interested in speaking on the proposed bylaw is encouraged to attend the public hearing or alternatively present a written submission no later than **June 20, 2018 (12:00 Noon)**. These written submissions will be included in the Council agenda package and should be clearly marked to include the Bylaw number. Oral submissions may be made at the Public Hearing without prior notification to the Town of St. Paul.

Please note that the Public Hearing for Bylaw No. 1249 will start at 7:30 p.m. followed by the Public Hearing for Bylaw No. 1250. The public hearings will occur sequentially, but those who wish to participate should be in attendance at 7:30 p.m. as each public hearing will commence as soon after 7:30 p.m. as any prior hearing is concluded. Submissions will become part of the public record, and, as such, will be subject to the provisions of the Freedom of Information and Protection of Privacy Act. A copy of the proposed bylaw can be obtained at the Town Hall (2nd Floor) during normal business hours.
