

PLANNING & DEVELOPMENT

Did you know....

A development permit is required if you wish to install a sign in town. Typically permits are required for A-frame signs, canopy signs, freestanding signs, temporary signs (1 per site), projecting signs, roof signs, fascia (wall) signs, inflatable signs, off-site signs. See page 125 in the Land Use Bylaw to confirm the regulations for a sign which requires a development permit. These types of signs do not require a permit: election signs, property for sale or rent signs, garage sale signs, and signs for not-for-profit organizations under Section 3.2 of the Land Use Bylaw.



A sign cannot be erected so as to obstruct the free and clear vision of vehicular and pedestrian traffic or where it may interfere with or be confused with any authorized traffic sign, signal or device. Signs cannot have display lights which may be mistaken for the flashing lights associated with danger or those used by police, fire, or other emergency vehicles. No part of a sign may encroach onto the adjacent site or a road or lane. All signs shall be maintained in good and safe structural condition and shall be periodically repainted.

If you have recently installed a sign on your property, it is not too late to apply for your permit to be in compliance with the Land Use Bylaw.


