Only 2 golfers per group. (unless proof is provided that you are living together)

1 person per cart. (unless proof is provided that you are living together)

Do NOT arrive more then 10 min before tee time.

No rental clubs or pull carts will be available.

Restaurant & Lounge will remain closed. (no food & beverage options will be offered)

10 minute tee-time intervals.

No touching the flag-stick at any time for any reason.

There will be raised cups.

No scorecards will be available.

No handshakes before or after your round.

No rakes, ball washers, water jugs or sand and seed holders will be on the course.

All golfers will be asked to leave the golf course immediately after playing to eliminate congestion/gathering on the property or in the parking lot.
